

## INNOVATION NATION APPLICATION TERMS AND CONDITIONS

1. Your application form and information on how to apply form part of these terms and conditions. By submitting an application form you are taken to have accepted these terms and conditions.
2. To apply, you must complete and submit the application form found at [innovation nation](#). Applications will not be accepted in any other form. You may only apply once.
3. FYA does not accept responsibility for late, lost, misdirected, ineligible, illegible or inaudible applications (including lost, stolen, forged, defaced or damaged proof of application).
4. Incomplete or ineligible applications will be deemed invalid. Applications that breach these terms and conditions will also be deemed invalid.
5. Your application must be your original work. FYA reserves the right to verify, or to require you to verify, that your application is your original work. If this cannot be verified to FYA's satisfaction, your application will be deemed invalid.
6. You are required to take full responsibility for the content (including text, images, sound and videos) of your application and for ensuring that your application complies with these terms and conditions. Your application must not include:
  - (a) any image or voice of any other person without that person's express consent. You warrant that if any such content is included in your application, you have obtained the express consent of the relevant person;
  - (b) any content that contravenes any law, infringes the rights of any person or is obscene, offensive, potentially defamatory, discriminatory, indecent or otherwise objectionable or inappropriate (which includes, without limitation, any content involving nudity, malice, excessive violence or swearing); and

Viability of the young person achieving the "change" (personal or project) given timeframe and \$1,000
  - Stage  
Have they started on their idea already
  - Connection  
Young person has experience and understanding of the challenge
  - Innovation  
Is this a new and creative method or idea
  - Diversity  
Does the Y.P come from a diverse background  
Does the project support people from a diverse background
12. The winning applicants will be notified by telephone or email within 30 days after the close of the Program (30 June 2016). If an applicant cannot be contacted within this time frame, FYA may in its absolute discretion award the Opportunity to another applicant or forfeit it.
13. The Opportunity (or any element of the Opportunity) is not transferable or exchangeable and cannot be taken as cash (other than the \$1,000 grant). If the Opportunity (or any element of the



Opportunity), is unavailable for any reason, FYA reserves the right to substitute or withdraw it.

14. FYA reserves the right at any time to disqualify any applicant who tampers with, or benefits from tampering with, the application process.
